An Act to provide for the establishment of Benazir Bhutto Shaheed University at Lyari Karachi.

WHEREAS it is expedient to provide for the Preamble. establishment of Benazir Bhutto Shaheed University at Lyari Karachi.

It is hereby enacted as follows:-

CHAPTER-I PRELIMINARY

1.	(1)	This Act may be called the Benazir Bhutto	Short title and
Shah	commencem		
			ent

(2) It shall be come into force at once.

2. In this Act and in all the Statutes, the Regulations and Definition. the Rules made there under, unless there is anything repugnant in the subject or context -

- (a)"Academic Council" means the Academic Council of the University;
- (b)"Affiliated college" means an educational institution, affiliated to the University but not maintained or administered by it;
- (c) "Authority" means any of the Authorities of the University specified in section19;
- (d) "Chancellor" means the Chancellor of the University;
- (e) "College" means a constituent college or an affiliated college;
- (f) "Commission" means Higher Education Commission;
- (g)"Constituent college" means a college maintained and administered by the University;
- (h) "Dean" means the Chairman or Chairperson of the Board of a Faculty;
- (i) "Director" means the head of a teaching Department or an institute established as a constituent institution by the University;
- (j) "educational institution" means an institution imparting instruction in a subject or subjects relating to a Faculty;

- (k) "Faculty" means a Faculty of the University;
- (I) "Government" means the Government of Sindh;
- (m) "Prescribed" means prescribed by statutes, regulations or rules;
- (n) "Principal" means the head of a college;
- (o) "Professional college" means a college providing for instruction in courses of study leading to a degree in medicine, engineering, agriculture, commerce, education, law, fine arts or such other subjects as may be prescribed by Regulations to be professional subjects;
- (p)"registered graduate" means -
 - (i) a graduate of the University who has his name entered in the register maintained for this purpose; or
 - (ii) a graduate of any other University who ordinarily resides within the territorial jurisdiction of the University and has his name entered in the register maintained by the University for this purpose;
- (q) "Research Officer" means a person engaged whole-time by the University for research and equivalent in rank to a University Teacher;
- (r) "Senate" means the Senate of the University;
- (s) "Statutes" "Regulations" and "Rules" mean respectively, the statutes, the regulations and the rules made or deemed to have been made under this Act and for the time being in force;
- (t) "Syndicate" means the Syndicate of the University;
- (u) "Teachers" include Professors, Associate Professors, Assistant Professors and Lecturers engaged wholetime by the University or by the college for teaching degree, honours or post-graduate classes, and such other persons as may be declared to be Teachers by Regulations;
- (v) "Teaching Department" means a teaching department maintained and administered or recognized by the University;
- (w) "University" means the Benazir Bhutto Shaheed University Lyari Karachi as constituted under this Act;
- (x) "University Teacher" means a whole-time Teacher

appointed and paid by the University, or recognized by the University as such; and

(y) "Vice-Chancellor" means the Vice-Chancellor of the University.

CHAPTER-II THE UNIVERSITY

3. (1) The Benazir Bhutto Shaheed University shall be Incorporation. constituted at Lyari Karachi in accordance with the provisions of this Act.

- (2) The University shall consist of -
 - (i) the Chancellor and the Pro-Chancellor, and -
 - (a) at the main campus, the Vice-Chancellor, Pro-Vice-Chancellor, Deans, Principals, Directors. Chairmen Teaching of Departments, Registrar, Director of Finance, Controller of Examinations, Chief Librarian. Accountant. Bursar. Resident Auditor and such other Officers as may be prescribed;
 - (b) at the Additional Campus, the Pro-Vice-Chancellor, Deans, Chairmen of Teaching Departments and such other Officers as may from time to time be appointed by the Chancellor on the recommendation of the Government.
 - the members of the Senate, the Syndicate, the Academic Council and other Authorities of the University;
 - (iii) all University Teachers; and
 - (iv) Emeritus Professors:

Provided that the Chancellor, on the recommendation of the Government, may set

up in any educational institution or college under the control and management of the University and establish a Board of Governors under section 37, in lieu of the Officers and employees mentioned in sub-clause (b) of clause (i).

(3) The University shall be a body corporate by the name of the Benazir Bhutto Shaheed University at Lyari Karachi and shall have perpetual succession and a common seal, and may sue and be sued by the said name.

(4) The University shall be competent to acquire and hold property, both movable and immovable, and to lease, sell or otherwise transfer any movable and immovable property which may have become vested in or been acquired by it.

4. The University shall have the powers –

(a) to provide for instruction in such branches of learning as it may deem fit, and to make provision for research and for the advancement and dissemination of knowledge in such manner as it may determine;

- (b) to prescribe courses of studies to be conducted by it and the colleges;
- (c) to hold examinations and to award and confer degrees, diplomas, certificates and other academic distinctions to and on persons who have been admitted to and have passed its examinations under prescribed conditions;
- (d) to confer honorary degrees or other distinctions on approved persons in the manner prescribed;
- (e) to provide for such instruction for persons not being students of the University as it may determine, and to grant certificates and diplomas to such persons;
- (f) to confer degrees on persons who have carried on independent research under prescribed conditions;
- (g) to affiliate and disaffiliate educational institutions

Powers of the University:-

under prescribed conditions;

- (h) to admit educational institutions to its privileges and to withdraw such privileges under prescribed conditions;
- to inspect colleges and other educational institutions associated or seeking association with it;
- (j) to accept the examinations passed and the periods of study spent by students of the University at other universities and places of learning as equivalent to such examinations and periods of study in the University, as it may determine, and to withdraw such acceptance;
- (k) to co-operate with other Universities and public authorities in such manner and for such purposes as it may determine;
- to institute Professorships, Associate Professorships, Assistant Professorships and Lecturerships and any other posts and to appoint persons thereto;
- (m) to create posts for research, extension, administration and other related purposes and to appoint persons thereto;
- (n) to recognize selected members of the teaching staff of affiliated colleges and colleges or educational institutions admitted to the privileges of the University or such other persons as it may deem fit, as University Teachers;
- to institute and award fellowships, scholarships, exhibitions, bursaries, medals and prizes under prescribed conditions;
- (p) to establish Teaching Departments, schools, colleges, Faculties, institutes, museums and other centers of learning for the development of teaching and research and to make such arrangements for their maintenance, management and administration as it may determine;

- (q) to control the residence of the students of the University and the colleges, to institute and maintain halls of residence and to approve or license hostels and lodgings;
- (r) to supervise and control the discipline of the students of the University and the colleges, to promote the extracurricular and recreational activities of such students, and to make arrangements for promoting their health and general welfare;
- (s) to demand and receive such fees and other charges as it may determine;
- (t) to make provision for research and advisory services and with these objects to enter into arrangements with other institutions or with public bodies under prescribed conditions:
- (u) to enter into, carry out, vary or cancel contracts;
- to receive and manage property transferred and (∨) grants, bequests, trusts, gifts, donations, endowments and other contributions made to University and to invest any fund the representing such property, grants, bequests, donations, trusts. aifts. endowments or contributions in such manner as it may deem fit;
- (w) to provide for the printing and publication of research and other works; and
- (x) to do all such other acts and things, whether incidental to the powers aforesaid or not, as may be requisite in order to further the objects of the University as a place of education, learning and research.

5. (1) Not withstanding any thing contained in any law Jurisdiction of the University shall have jurisdiction with in the limit of its the University. Campus and in respect of Colleges in such areas with in the Karachi as may be notified by Government:

Provided that Government may, in consultation with the University, by general or special order modify the Jurisdiction.

(2) No educational institution situated within the territorial limits of the University shall, save with the consent of the University and the sanction of Government, be associated in any way with or seek admission to the privileges of any other University.

(3) The University may admit to its privileges under prescribed conditions, an educational institution falling within the territorial limits of another university whether inside or outside Pakistan, provided that the consent of such other University is first obtained.

6. (I) The University shall be open to all persons of University either sex and of whatever religion, race, creed, class or open to all colour and no person shall be denied the privileges of the classes, University on the grounds of religion, race, caste, creed, class creeds etc. or colour:

> Provided that nothing in this section shall be deemed to prevent religious instruction being given to the students in their own religious faiths in such manner as may be prescribed.

(II) Not withstanding the provision of Sub-section (I) and other provision of this Act,50% of the total seats shall be reserved for the bonafide residents of the following backward areas of Karachi:-

- a) Lyari Town
- b) Kemari Town
- c) Malir Town; and
- d) Gadap Town.

7. (1) All recognized teaching in various courses shall Teaching in be conducted by the University or the colleges in the the University. prescribed manner and may include lecturers, tutorials, discussions, seminars, demonstrations as well as practical work in the laboratories, hospitals, workshops and farms and other methods of instruction.

(2) The authority responsible for organizing recognized teaching shall be such as may be prescribed.

(3) The courses and the curricula shall be such as may be prescribed.

CHAPTER-III OFFICERS OF THE UNIVERSITY

8. The following shall be the officers of the University:-

Officers of the University.

- (i) The Chancellor;
- (ii) The Pro-Chancellor;
- (iii) The Vice Chancellor;
- (iv) The Pro-Vice Chancellor;
- (v) The Deans;
- (vi) The Principals of the constituent colleges;

(vii) The Chairmen of the Teaching Departments:

- (viii) The Registrar;
- (ix) The Director of Finance;
- (x) The Controller of Examinations;
- (xi) The Chief Accountant;
- (xii) The Bursar
- (xiii) The Resident Auditor;
- (xiv) The Librarian; and
- (xv) Such persons as may be prescribed by the Regulations to be officers.

9. (1) The Governor of Sindh shall be the Chancellor of Chancellor. the University.

(2) The Chancellor shall, when present, preside at the Convocation of the University and the meetings of the Senate.

(3) If the Chancellor is satisfied that the proceedings of any Authority are not in accordance with the provisions of this Act, the Statutes, the Regulations, or the Rules, he may, after calling upon such Authority to show cause why such proceedings should not be annulled, by order in writing, annul the proceedings.

(4) Every proposal to confer an honorary degree shall be subject to confirmation by the Chancellor.

(5) The Chancellor shall have the power to assent to such Statutes as are required to be submitted to him by the

Senate or withhold assent and refer them back to the Senate for reconsideration.

- (6) The Chancellor may remove any person from the membership of any Authority if such person
 - (i) has become of unsound mind; or
 - (ii) has been incapacitated to function as member of such Authority; or
 - (iii) has been convicted by a court of law of an offence involving moral turpitude.
- (7) The Chancellor may, subject to the provisions of this Act, and general or special orders of Government, delegate all or any of the powers and functions of any authority, officer or employee of the University at its main campus, to any authority, officer, employee or any other person at its Additional Campus for the purpose of exercising such powers and performing such functions in relation to

such Additional Campus, and for this purpose the Chancellor in consultation with the Government may create new posts or positions at the Additional Campus.

10. (1) The Chancellor may, cause an inspection or Visitation. inquiry to be made in respect of any matter connected with the University, and shall, from time to time, appoint such person or persons in consultation with the Government for the purposes of carrying out inspection of –

- the University, its buildings, laboratories, libraries, museums, workshops and equipment;
- (ii) any institution, college or hostel maintained or recognized by, or affiliated to the University;
- (iii) the teaching and other work conducted by the University;
- (iv) the conduct of examinations held by the University; and
- (v) the Chancellor shall, in every such case as aforesaid, give notice to the Syndicate of his intention to cause an inspection or enquiry to e made, and the Syndicate shall be entitled to be represented thereat.

(2) The Chancellor shall communicate to the Syndicate his views with regard to the results of such inspection or inquiry and shall, after ascertaining the views thereon of the Syndicate, advise the Syndicate on the action to be taken.

(3) The Syndicate shall communicate to the Chancellor such action, if any, as has been taken or may be proposed to be taken upon the results of the inspection or inquiry. Such communication shall be submitted to the Chancellor within such time as may be specified by the Chancellor.

(4) Where the Syndicate does not, within a specified time, take action to the satisfaction of the Chancellor, the Chancellor may, after considering any explanation furnished or representation made by the Syndicate, issue such directions as he thinks fit, and the Vice-Chancellor shall comply with such directions.

The Minister for Education shall be the Pro- Pro-11. (1)Chancellor. Chancellor.

(2) Should the Chancellor be in capacitated from acting as such due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor.

There shall be a Vice-Chancellor of the University Vice-12. (1)who shall be an eminent academic or a distinguished Chancellor. administrator and shall be appointed by the Chancellor on the recommendation of Government.

At any time when the office of the Vice-Chancellor is (2) vacant, or the Vice Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the Chancellor shall make such arrangements for the performance of the duties of the Vice-Chancellor as he may deem fit.

13. The Vice-Chancellor shall be the principal Powers (1)executive and academic officer of the University and shall duties of the ensure that the provisions of this Act, the Statutes, the Vice-Regulations and the Rules are faithfully observed in order to Chancellor. promote the general efficiency and good order of the University. He shall have all powers necessary for this purpose

and

including administrative control over all officers, teachers and other employees of the University.

(2) The Vice-Chancellor shall, in the absence of the Chancellor and Pro-Chancellor, preside at the Convocation of the University and the meetings of the Senate and shall, if present, preside at the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.

(3) The Vice-Chancellor may, in an emergency which in his opinion requires immediate action, take such action as he may consider necessary and shall, as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.

- (4) The Vice-Chancellor shall also have the powers -
 - (i) to create and fill temporary posts for period not exceeding six months;
 - to sanction all expenditure provided for a in the approved budget, and to reappropriate funds within the same major head of expenditure;
 - (iii) to sanction by re-appropriation an amount not exceeding five thousand rupees for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;
 - (iv) to appoint paper setters and examiners for all examinations of the University after receiving panels of names from the relevant authorities;
 - (v) to make such arrangements for the scrutiny of papers, marks and results as he may consider necessary;
 - (vi) to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examination, administration and such other activities in the University as he may consider necessary for the purpose of the University;
 - (vii) to delegate, subject to such conditions, if

any, as may be prescribed, any of his powers under this Act to an officer or officers of the University:

- (viii) to exercise and perform such other powers and functions as may be prescribed; and
- to make appointments to the posts in all (ix)grades of the Basic Scales of pay up to BS-16.

14. The Chancellor may, on the recommendation of Pro-Vice-(1)the Government and in consultation with the Vice- Chancellor. Pro-Vice-Chancellor for the main Chancellor, appoint a campus or of the additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at a time as the Chancellor may determine.

(2) Where a Pro-Vice- Chancellor is appointed under subsection (1) he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice-Chancellor or such other powers and functions, in respect of the campus for which he is appointed, as the Chancellor may delegate to him.

(3) The Pro-Vice-Chancellor, if appointed, shall be exofficio member of the Senate, Syndicate and Academic Council and shall be deemed to be included in the University under sub-section (2) of section 3 and be an officer of the University under section 8.

15. The Registrar shall be a whole-time officer of the Registrar. University and shall be appointed by the Chancellor among the persons recommended by the Government. He shall –

- (a) hold office for three years on the expiry of which he shall be eligible for re-appointment;
- (b) be the custodian of the common seal and the academic records of the University;
- (c) maintain a register of registered graduates in the prescribed manner;
- (d) conduct election of members to the various authorities in the prescribed manner; and
- (e) perform such other duties as may be prescribed.
- 16. (1)The Director of Finance shall be a whole-time Director of

officer of the University and shall be appointed by the Finance. Chancellor among the persons recommended by the Government on such terms and conditions as may be prescribed. He shall –

- (a) manage the property, the finances and the investments of the University;
- (b) prepare the annual and revised budget estimates of the University and present Committee, the them to the Finance Syndicate and the Senate;
- (c) ensure that the funds of the University are expended on the purposes for which they are provided; and
- (d) perform such other duties as may be prescribed.
- (2) The Director of Finance shall be assisted by the Chief Accountant, Bursar and Resident Auditor.

17. The Controller of Examinations of the university, shall be Controller of a whole time officer of the University and shall be appointed Examinations:by the Chancellor among the persons recommended by the Government and shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed.

18. The Chief Accountant, Bursar and Resident Auditor The shall be whole-time officers of the University on such terms Accountant, and conditions as the Syndicate may determine. Bursar

Chief and Resident Auditor.

As the other remaining officers mentioned in section 8, 19. shall be appointed by such officer or authority as authorized by Government on such terms and conditions as it may determine. They shall perform their duties as may be prescribed.

- 21. (1) The Senate shall consist of
 - (i) the Chancellor;
 - (ii) the Pro-Chancellor;
 - (iii) the Vice-Chancellor;
 - (iv) the Pro-Vice Chancellor, if appointed,
 - (v) the Members of the Syndicate;
 - (vi) the Deans;

(vii) the Directors;

(viii) the Principals of the constituent colleges;

(ix) the University Professors and Emeritus Professors;

(x) the Chairmen of the Teaching Departments;

- (xi) the Officer or Teacher Incharge of Students' Affairs (by whatever designation called);
- (xii) three Principals of affiliated colleges to be elected by the Principals of all such colleges from amongst themselves;
- (xiii) twelve Teachers of affiliated colleges having at least three years' service in an affiliated college to be elected by the teachers of all such colleges from amongst themselves;
- (xiv) Chairman of the Boards of Intermediate and Secondary Education located within the jurisdiction of the University;
- (xv) Chairman of the Board of Technical Education;
- (xvi) twelve University Teachers having at least three years service to be elected by all University Teachers;
- (xvii) two registered graduates to be elected by all such graduates from amongst themselves; (xviii) three persons eminent in the Arts, Sciences and the

Senate.

Professions, one from each category;

(xviii) the Registrar;

- (xix) the Director of Finance:
- the Controller of Examinations; and $(\mathbf{x}\mathbf{x})$
- (xxi) the Librarian:
- (2) The Chancellor or in his absence, the Pro-Chancellor or in absence of both, the Vice-Chancellor shall be the Chairman of the Senate.
- Members of the Senate, other than ex-officio (3) members shall hold office for three years.
- (4) The Senate shall meet at least twice in every year on dates to be fixed by the Vice-Chancellor with the consent of the Chancellor.
- (5) The quorum for a meeting of the Senate shall be one-third of the total number of members, a fraction being counted as one.

Subject to the provisions of this Act, the Senate shall Powers 22. and have the powers -

- (a) to consider the drafts of Statutes proposed by the Syndicate and deal with them in the manner indicated in sub-section (2) of section 29;
- to consider and pass resolution on the (b) annual report, the annual statement of accounts, and the annual and revised budget estimates;
- (C) to appoint members to the Syndicate and other Authorities in accordance with the provisions of this Act;
- (d) to delegate any of its powers to an Authority or Officer or a Committee or Sub-Committee: and
- to perform such other functions as may (e) be prescribed by Statutes.
- 23. (1) The Syndicate shall consist of -

Syndicate.

- (i) the Vice-Chancellor, who shall be its Chairman:
- (ii) the Pro-Vice-Chancellor, if appointed;
- (iii) three members of the Provincial Assembly to be nominated by the Speaker of Provincial Assembly, Provided that atleast one Member of Provincial Assembly shall be from Lyari Town.
- (iv) one Member of National Assembly from Lyari Town;
- (v) the Chief Justice of the High Court of Sindh or a Judge of the High Court nominated by him;
- (vi) Secretary to the Government of Sindh, Education Department or his nominee not below the rank of an Additional Secretary;
- (vii) one nominee of the Higher Education Commission;
- (viii) one Dean to be nominated by the Chancellor on the recommendations of the Vice-Chancellor;
- (ix) one Professor to be elected by the Professors of the University from amongst themselves;
- (x) one Associate Professor to be elected by the Associate Professors of the University from amongst themselves;
- (xi) one Assistant Professor of the University to be elected by the Assistant Professors from amongst themselves;
- (xii) one lecturer with minimum service of two years to be elected by the lecturers of the University from amongst themselves;
- (xiii) three persons of eminence to be nominated by the Chancellor among the persons recommended by the Government;
- (xiv) one Principal of an affiliated college to be nominated by the Chancellor among the persons recommended by the Government; and
- (xv) one Alim and one woman not serving in any educational institution to be nominated by the Chancellor among the persons recommended by the Government;

(2) Members of the Syndicate, other than ex-officio members, shall hold office for three years.

(3) The quorum for a meeting of the Syndicate shall be one-half of the total number of members, a fraction being counted as one.

24. (1) The Syndicate shall be the executive body of the Powers and University and shall, subject to the provisions of this Ordinance duties of and the Statutes, exercise general supervision over the affairs Syndicate. and management of the property of the University.

(2) Without prejudice to the generality of the foregoing powers, and subject to the provisions of this Act and the Statutes, the Syndicate shall have the powers –

- (a) to hold, control and administer the property and funds of the University;
- (b) to govern and regulate, with due regard to the advice of the Finance and Planning Committee in this behalf, the finances, accounts and investments of the University and for that purpose, to appoint such agents as it may think fit;
- (c) to consider annual report, the annual and revised budget estimates and to advise the Senate thereon, and to re-appropriate funds from one major head of expenditure to another;
- (d) to transfer and accept transfer of movable or immovable property on behalf of the University;
- (e) to enter into, vary, carry out and cancel contracts on behalf of the University;
- (f) to cause proper books of account to be kept for all sums of money received and expended by the University and for the assets and liabilities of the University;
- (g) to invest any money belonging to the University including any unapplied income in any of the securities described in section 20 of the Trusts Act, 1882 (Act II of 1882), or in the

purchase of immovable property or in such other manner, as it may determine, with the like power of varying such investments;

- (h) to receive and manage any property transferred and grants, bequests, donations, endowments and other contributions made to the University;
- to administer any funds placed at the disposal of the University for specified purposes;
- (j) to determine the form, provide for the custody and regulate the use of the common seal of the University;
- (k) to provide the buildings, libraries, premises, furniture, apparatus, equipment and other means required for carrying out the work of the University;
- to establish and maintain halls of residence and hostels or approve or license hostels or lodgings for the residence of students;
- (m) to affiliate and disaffiliate colleges;
- (n) to admit educational institutions to the privileges of the University and withdraw such privileges;
- (o) to arrange for the inspection of colleges and the Teaching Departments;
- (p) to institute Professorships, Associate Professorships, Assistant Professorships, Lecturerships, and other teaching posts or suspend or to abolish such posts;
- (q) to create, suspend or abolish such administrative, research, extension or other posts as may be necessary;
- (r) to make appointments on the recommendations of the Selection Board to

the posts in Grade 17 and above of the National Scales of Pay;

- (s) to appoint Emeritus Professors on such terms and conditions as may be prescribed;
- (t) to confer Honorary Degrees in accordance with the conditions prescribed;
- (u) to prescribe the duties of Officers, Teachers, and other employees of the University;
- (v) to suspend, punish and remove from service Officers (other than the Vice-Chancellor), Teachers and other employees in the manner prescribed;
- (w) to report to the Senate on matters on which it has been asked to report;
- (x) to appoint members to the various Authorities in accordance with the provisions of this Act;
- (y) to propose drafts for Statutes for submission to the Senate;
- (z) to consider and deal in the manner prescribed in subsection (2) of section 30, the Regulations made by the Academic Council; provided that the Syndicate may frame a Regulation at its own initiative and approve it after calling for the advice of the Academic Council;
- (aa) to regulate, determine and administer all other matters concerning the University and to this end exercise all other powers not specifically mentioned in this Act and the Statutes;
- (bb) to delegate any of its power to an Authority or Officer or a Committee or Sub-Committee; and
- (cc) to perform such other functions as have been assigned to it by the other provisions of this

- (xi) four Principals of affiliated colleges to be elected by the Principals of all such colleges from amongst themselves, of whom at least one shall be from professional colleges and one from the women's colleges;
- (xii) five Teachers of affiliated colleges having at least five years' service in an affiliated college, other than the Principals, to be elected by the Teachers of all such colleges from amongst themselves, of whom at least one shall be from professional colleges and one from the women's colleges;
- (xiii) three persons eminent in the arts, the sciences and the professions, of whom one shall be from each category, to be nominated by the Chancellor among the persons recommended by the Government;
- (xiv) the Registrar;
- (xv) the Librarian; and
- (xvi) the Controller of Examinations.

(2) Members appointed by nomination or election shall hold office for three years.

(3) The quorum for a meeting of the Academic Council shall be one-third of the total number of members.

- (g) to make Regulations, on the recommendations of the Boards of Faculties and the Boards of Studies, prescribing the courses of studies, the syllabi and the outlines of tests for all University examinations; provided that if the recommendations of the Board of a Faculty or a Board of Studies are not received by the prescribed date, the Academic Council may, subject to the approval of the Syndicate, continue for the next year the courses of studies already prescribed for an examination;
- recognize the examinations (h) to of other Universities or examining bodies as equivalent to the corresponding examinations of the University;
- regulate the award of studentships, (i) to scholarships, exhibitions, medals and prizes;
- (i) to frame Regulations for submission to the Syndicate:
- (k) to appoint members to the various Authorities in accordance with the provisions of this Act; and

CHAPTER-V STATUTES, REGULATIONS AND RULES

29. Subject to the provisions of this Act, Statutes may Statutes. (1)be made to regulate or prescribe all or any of the following matters:-

- (a) the constitution of pension, insurance, gratuity, provident fund and benevolent fund for University employees;
- (b) the scales of pay and other terms and conditions of service of Officers, Teachers and other employees of the University;
- (c) the maintenance of the register of registered graduates;
- (d) affiliation and disaffiliation of educational institutions and related matters:
- (e) admission of educational institutions to the privileges of the University and the withdrawal of such privileges;
- (f) the conduct of elections for membership of the Authorities of the University and related matters;
- (g) the establishment of Faculties, institutes and colleges and other academic Divisions;
- (h) the powers and duties of Officers and Teachers;
- (i) conditions under which the University may enter into arrangements with other institutions or with public bodies for purposes of research and advisory services:
- (i) conditions for appointment of Emeritus Professors and award of honorary degrees;

- (k) efficiency and discipline of University employees:
- (I) the general scheme of studies including the duration of courses and the number of subjects and papers for an examination; and
- (m) all other matters which by this Act are to be or may be prescribed or regulated by Statutes.
- (2) The draft of Statutes shall be proposed by the Syndicate to the Senate which may approve it or pass it with such modifications as the Senate may think fit, or may refer it back to the Syndicate for reconsideration, or may reject it:

Provided that the Syndicate shall not propose draft of Statutes affecting the constitution or powers of any Authority of the University, until such Authority has been given an opportunity of expressing an opinion in writing upon the proposal:

Provided further that the draft of Statutes concerning any of the matters mentioned in clauses (a) and (b) of subsection (1), shall be forwarded to the Chancellor and shall not be effective until it has been approved by the Chancellor:

Provided also that Statutes concerning any of the matters mentioned in clause (k) of sub-section (1) shall be made by the Chancellor.

30. (1) Subject to the provisions of this Act and the Regulations. Statutes, Regulations may be made for all or any of the following matters:-

- (a) the courses of study for degrees, diplomas and certificates of the University;
- (b) the manner in which the recognized teaching referred to in sub-section (1) of section 7 shall be organized and conducted;
- (c) the admission of students to the University;
- (d) the conditions under which students shall be admitted to the courses and the examination of the University shall become eligible for the award of degrees, diplomas and certificates;
- (e) the conduct of examinations;

- fees and other charges to be paid by students (f) for admission to the courses of study and examinations of the University:
- (g) the conduct and discipline of students of the University;
- (h) conditions of residence of the students of the University or the colleges, including the levying of fees for residence in halls of residence and hostels:
- the approval and licensing of hostels and (i) lodgings;
- conditions under which a person should carry (j) on independent research to entitle him to a dearee:
- the institution of fellowships, scholarships, (k) exhibitions, medals and prizes;
- (1) the institution of stipends and free and half-free studentships;
- (m) the academic costume;
- (n) the use of Library;
- (o) the formation of Teaching Departments and Boards of Studies; and
- (p) all other matters which by this Act and the Statutes are to be or may be prescribed by Regulations.

(2) The Regulations shall be prepared by the Academic Council and shall be submitted to the Syndicate which may approve them or with hold approval or refer them back to the Academic Council for reconsideration. A Regulation prepared by the Academic Council shall not be valid, unless it receives the approval of the Syndicate.

The procedure for adding to, amending or repealing Amendment 31. the Statutes and the Regulations shall be the same as that and repeal of prescribed respectively for framing or making Statutes and Regulations.

The Authorities and the other bodies of the Rules. 32. (1)University may make Rules consistent with this Act, Statutes and the Regulations, to regulate the conduct of their business and the time and place of meetings and related matters:

Provided that the Syndicate may direct the amendment or the annulment of any Rules, made by another Authority or body excepting the Senate, under

(2) The Syndicate may make Rules to regulate any matter relating to the affairs of the University which has not been specifically provided for by this Act, the Statutes or Regulation.

CHAPTER-VI

AFFILIATION OF EDUCATIONAL INSTITUTIONS TO THE UNIVERSITY

33. (1) An educational institution applying for affiliation Affiliation. to the University shall make an application to the University and shall satisfy it -

- (i) that the educational institution is under the management of the Government or of a regularly constituted governing body;
- (ii) that the financial resources of the educational institution are sufficient to enable it to make due provision for its continued maintenance and efficient working;
- (iii) that the strength and qualifications of the teaching and other staff, and the terms and conditions of their service, are adequate to make due provision for the courses of instruction, teaching or training to be undertaken by the educational institution;
- (iv) that the educational institution has framed proper rules regarding the efficiency and discipline of its staff and other employees;
- (v) that the building in which the educational institution is to be located is suitable, and that provision will be made inconformity

with the Statutes and the Regulations for the residence of students, not residing with their parents or guardians, in the hostels established and maintained by the educational institution or in hostels or lodgings approved by it, and the supervision and physical and general welfare of students;

- (vi) that provision has been made for Library and adequate library services;
- (vii) that where affiliation is sought in any branch of experimental sciences, due arrangements have been made for imparting instruction in that branch of science in a properly equipped laboratory, museum and other places of practical work;
- (viii) that due provision will, so far as circumstances may permit, be made for the residence of Principal and members of the teaching staff in or near the college or the place provided for the residence of students; and
- (ix) that the affiliation of the educational institution, having regard to the provision which may have been made for students by another educational institution in its neighborhood, will not be injurious to the interests of education or discipline.

(2) The application shall further contain an undertaking that after the educational institution is affiliated any transference of, and changes in the management and in the teaching staff shall be forthwith reported to the University, and that the teaching staff shall possess such qualifications as are or may be prescribed.

(3) The procedure to be followed in disposing of an application for the affiliation of an educational institution shall be such as may be prescribed.

(4) The Syndicate may, on the recommendation of the

Affiliation Committee, grant or refuse affiliation to an educational institution:

Provided that affiliation shall not be refused, unless the educational institution has been given an opportunity of making a representation against the proposed decision.

34. Where an educational institution desires to add to the Addition courses of instructions in respect of which it is affiliated, the courses procedure prescribed under sub-section (3) of section 32 affiliated shall, so far as may be ,be followed.

35. (1) Every educational institution affiliated to the Reports fro University shall furnish such reports, returns and other affiliated information as the University may require to enable it to judge educational the efficiency of the educational institution. institutions.

(2) The University may call upon any educational institution affiliated to it to take, within a specified period, such action as may appear to the University to be necessary in respect of any of the matters referred to in sub-section (1) of section 32.

Addition of courses by affiliated educational institution. Reports from affiliated educational institutions.

36. (1) If an educational institution affiliated to the Withdrawal of University fails at any time to fulfill any of the requirements affiliation. mentioned in this Act, or if an institution has failed to observe any of the conditions of its affiliation, or its affairs are conducted in a manner which is prejudicial to the interest of education, the Syndicate may, on the recommendation of the Affiliation Committee, and after considering such representation as the educational institution may wish to make, withdraw, either in whole or in part, the rights conferred on the., educational institution by affiliation or modify such rights.

(2) The procedure to be followed for the withdrawal of affiliation shall be such as may be prescribed.

37. An appeal shall lie to the Senate against the decision Appeal of the Syndicate refusing to affiliate an institution, or against refusal withdrawing in whole or in part the rights conferred on an institution by affiliation or modifying such rights. of affiliation.

38. (1) The Chancellor may, on request of .any affiliated Taking over of

(2) The Chancellor may, for the efficient management and control of such educational institution or college on the recommendation of Government, establish a Board of Governors.

- (3) The Board of Governors shall consist of
 - (i) the Pro-Chancellor Chairman
 - (ii) the Vice-Chancellor Vice-Chairman
 - (iii) such other Members as may be appointed by the Chancellor on the recommendation of the Government.
- (4) Subject to special or general direction of the Chancellor the Board of Governors shall exercise general supervision and control over the affairs of such institution or college and without prejudice to the generality of these powers it shall –
 - (a) formulate the policy for running the institution or college in the light of guide lines issued by the University from time to time;
 - (b) control and administer the property of the institution or college;
 - (c) manage and regulate the funds, finances, assets and investments of the institution or college;
 - (d) maintain the accounts of the institution or college in the prescribed form and get such accounts audited in the prescribed manner; and
 - (e) appoint teachers and other employees of the institution or college and have the power to take disciplinary action against them.

CHAPTER-VII UNIVERSITY FUND

39. The University shall have a fund to which shall be University credited its income from fees, donation, trusts, bequests, Fund.

40. (1)The accounts of the University shall be Audit and maintained in such form and in such manner as may be Accounts. prescribed.

(2) No expenditure shall be made from the funds of the University, unless a bill for its payment has in accordance the Statutes, been audited by the Resident Auditor with appointed by the Provincial Audit Department and the payment is included in the approved budget of the University.

The annual statement of the accounts of the University (3) Signed by the Director of Finance and the Resident Auditor shall be submitted to Government within six months of closing of the financial year.

(4) The accounts of the University shall be audited once a year in conformity with the Statutes, Regulations and Rules by the Auditor appointed by Government for this purpose.

The observations of Government Auditor, together with (5) such annotations as the Director of Finance may make shall be presented to the Syndicate.

CHAPTER-VIII GENERAL PROVISIONS

41. Except as otherwise provided no Officer, Teacher or Opportunity other employee of the University holding a permanent post to shall be reduced in rank, or removed or compulsorily retired cause. from service unless he has been given a reasonable opportunity of showing cause against the action proposed to be taken.

42. Where an order is passed punishing any Officer (other than the Vice-Chancellor), Teacher or other employee of the University or altering or interpreting to his disadvantage the prescribed terms or conditions of his service, he shall, where the order is passed by the Vice-Chancellor or any other Officer or Teacher of the University, have the right to appeal to the Syndicate against the order, and where the order is made by the Syndicate, have the right to apply to that authority for review of that order. The appeal or application for review shall be submitted to the Vice-Chancellor and he

43. An officer, teacher or other employee of the University Age of shall retire from service superannuatio

- on such date, after he has completed (i) twenty five years of service qualifying for pension or other retirement benefits, as the competent authority may direct; or
- where no direction is given under clause (i) (ii) on the completion of sixty years age.

Explanation:- In this section "competent authority" means the appointing authority or a person duly authorized by the appointing authority in that behalf, not being a person lower in rank to the officer, teacher or other employee concerned.

44. (1)The University shall constitute for the benefit of its Pension, officers, teachers and other employees in such manner and Insurance, subject to such conditions as may be prescribed, such pension, insurance, gratuity, provident fund and benevolent fund scheme as it may deem fit.

Where any provident fund has been constituted under Fund. (2) this Act, the provisions of the Provident Funds Act, 1925 (Act-XIX of 1925) shall apply to such funds as if it were the Government Provident Fund.

45. When a member of a newly constituted Commencem (1)Authority is elected, appointed or nominated, his term office, as fixed under this Act, shall commence from such office date as may be prescribed.

(2) The Boards of Faculties in Arts, Science, Business Administration and shall each consist of –

- (i) the Dean;
- (ii) the Professors and the Chairmen of the Teaching Departments comprised in the Faculty;
- (iii) one Lecturer, one Assistant Professor and one Associate Professor, each to be appointed by rotation in order or seniority from each Department; and
- (iv) three teachers to be nominated by the Academic Council by reason of their specialized knowledge of the subjects which, though not assigned to the Faculty, have in the opinion of the Academic Council important bearing on the subjects assigned to the Faculty.

(3) The Boards of Faculties in Education, Law and Medicine shall each consist of -

- (i) the Dean;
- (ii) the Professors;
- (iii) two members of each Board of Studies, comprised in the Faculty, to be nominated by the Board of Studies concerned; and
- (iv) three teachers to be nominated by the Academic Council by reason of their specialized knowledge of

subjects which, though not assigned to the Faculty, have in the opinion of the Academic Council, important bearing on the subjects assigned to the Faculty.

- (4) The members mentioned in sub-clauses (iii) and (iv) of clause (3) shall hold office for three years.
- (5) The quorum for a meeting of the Board of a Faculty shall be one half of the total number of members, a fraction being counted as one.
- (6) The Board of each Faculty shall, subject to the general control of the Academic Council and the Syndicate, have the powers
 - (a) to coordinate the teaching and research work in the subjects assigned to the Faculty;
 - (b) to scrutinize the recommendation of the Boards of Studies comprised in the Faculty in regard to the appointment of paper setters and examiners, except for research examinations, and to forward the panels of suitable paper setters and examiners for each examination to the Vice-Chancellor;
 - (c) to consider any other academic matter relating to the Faculty and to report thereon to the Academic Council; and
 - (d) to perform such other functions as may be prescribed by Statutes.

2. (1) There shall be a Dean of each Faculty who shall be the **Dean**. Chairman and convener of the Board of Faculty.

(2) The Dean of each Faculty shall be appointed by the Chancellor on the recommendations of the Vice-Chancellor from amongst, the three most senior Professors in the Faculty for a period of three years.

(3) The Dean shall present candidates for admission to degrees, except honorary degrees, in the courses falling within the purview of the Faculty.

(4) The Dean shall exercise such other powers and perform such other duties as may be prescribed.

3. (1) There shall be a Teaching Department for each subject or a **Teaching** group of subjects, as may be prescribed by Regulations, and each **Department**.

Teaching Department shall be headed by a Chairman.

(2) The Chairman or Chairperson of a Teaching Department or Director of an Institute shall be appointed by the Syndicate on the recommendations of the Vice-Chancellor from amongst three most senior Professors and three most senior Associate Professors of the Department for a period of three years.

Provided that where there is no Professor or Associate Professor in a Department, it shall be looked after by the Dean of the Faculty with the assistance of the most senior teacher of the Department.

(3) The Chairman of the Department shall plan, organize and supervise the work of the Department and shall be responsible to the Dean for the work of his Department.

4. (1) There shall be a separate Board of Studies for each subject **Boards** or group of subjects, as may be prescribed by Regulations. **Studies.**

(2) Each Board of Studies shall consist of –

- (i) the Chairman of the Teaching Department;
- (ii) all Professors and Associate Professors in the University Teaching Department;
- (iii) three Assistant Professors and one Lecturer to be appointed by rotation in order of seniority from the Department concerned;
- (iv) three teachers other than University teachers to be appointed by the Syndicate. The number will be determined by the Syndicate according to the need of each Board; and
- (v) one expert to be appointed by the Vice-Chancellor.

Provided that in the case of subjects, which are taught in the teaching departments or, constituents colleges only, such as Law, Commerce, Social Work, Journalism, Geology, the Board of Studies shall consist of –

- (a) the Chairman of the University Teaching Department;
- (b) all Professors and Associate Professors in the University Teaching Department;
- (c) one Assistant Professor and one Lecturer by rotation in order of seniority from the Department concerned; and
- (d) four experts to be appointed by the Vice-Chancellor:

Provided that in the case of Professional subjects

which are taught in the affiliated colleges only, and not in the University, such as Medicine, Animal Husbandry, Dentistry, Home Economics, Engineering, Agriculture, the Board of Studies shall consist of –

- (a) the Principals of the colleges concerned;
- (b) five Teachers of the colleges, to be appointed by the Syndicate; and
- (c) two experts to be appointed by the Vice-Chancellor:

Provided that in the case of such subjects of Humanities and Sciences as are taught in the affiliated colleges only and not in the University, the Board of Studies shall consist of –

- (a) six Teachers from the colleges doing teaching work in the subject to be appointed by the Academic Council; and
- (b) one expert to be appointed by the Vice-Chancellor.

(3) The term of office of members of the Board of Studies other than ex-officio members shall be three years.

(4) The quorum for meetings of the Board of Studies shall be one-half of the total number of members, a fraction being counted as one.

(5) The Chairman of the University Teaching Department concerned shall be the Chairman and convener of the Board of Studies. Where in respect of a subject there is no University Teaching Department, the Chairman shall be appointed by the Syndicate.

(6) The functions of the Board of Studies shall be –

- (a) to advise the Authorities on all academic matters connected with instruction, research and examination in the subject or subjects concerned;
- (b) to propose curricula and syllabi for all degree, diploma and certificate courses in the subject or subjects concerned;
- (c) to suggest a panel of names of paper setters and examiners in the subject or subjects concerned; and
- (d) to perform such other functions as may be prescribed by Regulations.

7. (1) The Selection will consider the applications received in **Functions of** response to merit and recommend to the Syndicate the names of suitable **Selection Board.** candidates for appointment to teaching and other posts.

(2) The Selection Board may recommend the grant of a higher initial pay in a suitable case for reasons to be recorded.

(3) The Selection Board may recommend to the Syndicate the **appointment** of an eminently qualified person to a Professorship in the University on the terms and conditions other than those prescribed.

(4) In the event of an unresolved difference of opinion between the Selection Board and the Syndicate, the matter shall be referred to the Chancellor whose decision shall be final.
